- In rented accommodations and camping pitches, arrivals from 2 p.m. and departures before 10 a.m.. Any delay returning the key and leaving the pitch after 12 p.m. will be invoiced as one extra night. Should your stay be extended, you must inform the establishment at least 24 hours before the departure
 - Booking requests for pitches are nominative and nontransferable.
 - The number of persons staying on the site shall in no case be higher than that indicated in this contract, even for one night.
 - Every person coming to visit you must be declared to the office to pay the current price for security and insurance purposes. By default, the person or persons will be considered as unregistered and therefore uninsured .
 - The lease is only effective after the establishment has agreed and received the deposit and the administration fees. The balance must be paid 30 days before your arrival. If the balance is not paid, your reserved accommodation may be allocated to another customer and your desposit not refunded.
 - Campsite stays without reservation are payable in full on the day of arrival.
 - No discount will be guaranteed or late arrivals and/ or early departures. For any modification to the reservation, the same place cannot be guaranteed.
 - The cancellation always has to be writing.
- In case of cancellation, the booking fee and insurance (if any) will be retained by way of compensation for breach of contract.
 - An amount equal to 20 % of the complete cost of the stay if you cancel more than 30 days before the planned date of arrival.
 - An amount equal to the totality of the stay if you cancel less than 30 days before the planned date of arrival, or if you do not arrive for your stay.
 It is recommended to sign an insurance cancellation. .
- All guests are required to comply with the regulations of the campsite (including the swimming pool : swimwear compulsory, shorts not allowed) .
 - The establishment is not liable for any damages to the holiday-maker's equipment. Holiday-makers must have subscribed to civil liability insurance for their equipment (FFCC, ANWB, ADAC, etc.) .
 - Ground fires are prohibited. Traffic is regulated. For safety reasons, motor vehicles should be parked in spaces. Barbecues are available on the site with usual precautions. Electric barbecues are prohibited.
 - Vaccination is mandatory for animals. Certain categories of dogs (1 and 2) are prohibited.
 - These general conditions are subject to French law and all disputes concerning their application falls under the jurisdiction of the High Court or Tribunal de Commerce de Brive la Gaillarde.
